Access funding and assets for local economic and community development

Set-up, buy and own local assets and enterprises

Understand the value of local asset ownership and how it can contribute to long-term community well-being. Learn about strategies to enable local people and communities to set-up, purchase and own local assets of all kinds such as land, property, businesses, infrastructure, equipment, data, IP.

Govern and manage local finance, assets, enterprises and services

Explore governance models that promote local leadership, decision-making, transparency and long-term stewardship of community assets, funding and development. Learn how to manage capital—such as land, resources, and businesses—for the benefit of local people and organisations



Pool capital for collective impact

Learn how to bring people and organisations together to pool capital for collective investment, strengthening the community's ability to fund significant projects, diversify investment risk and build financial resilience.

Invest and store capital in the community

Explore ways to activate investment in community-driven projects, local businesses, services and development. Discover investment strategies that prioritise local investors and enable co-investment with external partners to ensure local people retain a meaningful stake.

Strategically use capital to benefit the community, lead development and unlock opportunities

Learn to use capital to drive community-led planning, development and build essential infrastructure, services, and businesses that improve quality of life while ensuring essential services and commercial opportunities are in community hands.

Reinvest capital and foster local circular wealth

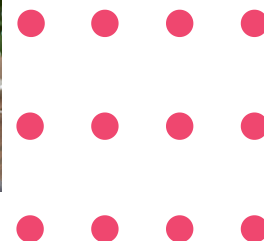
Explore strategies for reinvesting profits and benefits back into the community, fostering a circular economy that continuously generates local wealth and development opportunities.

Why Place Based Capital?

Place based capital empowers communities by creating local capital systems that are grounded in place, focused on people, and driven by local ownership, decision-making, inclusion, equity and wealth retention. Unlike traditional models that often leave communities dependent on external funding and control, place based capital is built on the belief that thriving communities are those that can control and directly benefit from their own assets and capital.

This approach enables communities to establish locally led and owned enterprises, generate sustainable funding sources and manage valuable assets like land, infrastructure, and natural resources to improve their quality of life. Achieving this vision requires both local action and the support of aligned partners, including governments, industry, developers, investors, philanthropists and for-purpose organisations.

By fostering self-sufficiency, place based capital equips communities with the essential tools they need—financial resources, assets, enterprises, and local control—to address their unique challenges, from affordable housing and job creation to economic participation and the shift to a circular, sustainable economy.

Rather than addressing capital needs in a piecemeal, grant-by-grant basis, place based capital offers a strategic and systematic approach that enables communities to build a strong capital foundation, unlock capital for a range of opportunities, and achieve long-term prosperity for all.
